
REUNIFICATION DISCERNMENT

Town Hall Forums: July 2024





October 2022

A resolution adopted at both of our diocesan conventions called for "a period of intentional exploration" regarding the "future reunification as one diocese." The Reunification Discernment Committee was appointed and began our work in January 2023.

Both diocesan conventions passed a second resolution in support of this process, extending this discernment around reunification and charging the Reunification Discernment Committee with preparation of recommendations regarding reunification to be presented to the Conventions in Fall 2024.



Our Process:

EXPLORE, LISTEN, INFORM, DISCERN

- Phase I (2023) Exploration (Gather Data & Input)
- Phase II (2023-24): Collate and Analyze Data/Listening Sessions
- Phase III (2024): Consider Models for Reunification
- Phase IV (2024): Propose Reunification Models & Timeline
- Phase V (2024): Present Resolutions for a Joint Convention

WHY REUNIFICATION?

- The Data (financial, attendance, clergy). It's painful to acknowledge but we need to name that as church, one of the things we are experiencing is various forms of decline. Any community or system with these numbers would need to adapt.
- Better Stewardship: To carry on as is or to simply collaborate as two dioceses will continue to deplete our resources, human and financial.
- The Questions are the Same: We have to face the big challenges whether we stay separate or reunify. The question is whether we can face them better together, as one. And we believe we can.

WHY REUNIFY NOW?

So the Episcopal Church will be here tomorrow:

Reunification is work to do now, but it is for the sake of ensuring the Episcopal Church's presence here BEYOND our lifespan, for future generations.

The movement of reunification is grounded in love for our church, gratitude for all who are our church and those who have served and given for generations. Collectively, we can keep the heart of our traditions alive and better serve a world hungry for the good news Episcopalians have to share. We must adapt in order to thrive - into the future.

• We aren't in crisis...yet. We can still be creative about how we do this. There are still resources, strengths, potentials to help us adapt well. Our coming together can be filled with gratitude and inspire hope.


REGIONAL STRUCTURE








Parishes By County for Each Diocese

CONSTITUTION & CANONS

- Most of the Constitution & Canons of our two dioceses - 28 articlesare similar which is enabling a draft C&C for a reunified diocese to be written without great changes.
- 8 articles will need mutual attention during the transition year, such as deciding on the exact composition of various leadership bodies, etc. All of these are manageable and none a stretch for either diocese.
- The details for transitioning into one diocese will need to be refined but the canons themselves provide similar structure and process.

STEWARDSHIP of FINANCIAL RESOURCES

BUDGETING AND APPORTIONMENT FOR A REUNIFIED DIOCESE

- Reunification models indicate we can set an apportionment goal within 1% of current practices.
- For 2026, figuring annual inflation and no staffing changes, we would have a \$3.5 million total budget for a reunified diocese.
- If we remained separate, using the same process of modeling, our budgets would total at least \$4.1 million.
- With no changes, we would see an annual savings of \$600,000 or 14%.

FINANCES and the TIMELINE

- 2025 The Transition Year
 - Separate dioceses with separate budgets
 - Form a Joint Finance Committee for planning, structuring as one
- 2026 A Reunified Diocese
 - Apportionment goal of within 1% of current practices
 - Savings by reducing duplication of systems, processes, software, office expenses...
 - Staffing as a hybrid of centralized and disbursed

AS WE'VE SHARED BEFORE...

- Our dioceses have similar financial resources.
- Neither diocese holds any significant indebtedness other than funds held on behalf of parishes.
- The dioceses are very similar in terms of membership, number of parishes, staffing and financial resources.

Ministry of the Episcopate

If we reunify, one of our current bishops would become

Bishop Diocesan in **January 2026**, the other would be appointed as **Assistant Bishop**, dependent on continuing discernment.

The **Reunified Diocese** would host its first search and election process on a timeline to be determined by its Bishop Diocesan and Standing Committee.

This model aligns with both Bishop Scanlan's and Bishop Nichols' hopes for this potential reunification process, Bishop Scanlan's retirement timeline, and the sense they each have of their own ministry and calling.

We have considered...

- Visitations
- Staffing
- Diocesan Cultures

There will be some letting go.

- Deputies to General Convention will decrease.
- Some of our familiar ways of operating will change.
- We'll have a new name.
- We will let go of these particular bishops (which will eventually happen anyway at some point either way.)

Why Reunify?

In the ordinal says that a bishop is called to "guard the faith, unity, and discipline" of the church. We see collaboratively supporting a movement toward reunification as a dimension of that call.

As bishops we see that our current model of diocese is time limited, closing one to two churches per year and watching diocesan income and resources decline. We want the faith to live! Reunification offers opportunity to unite and renew for the sake of the faith and the presence of the Episcopal Church in our region now and for the future.


