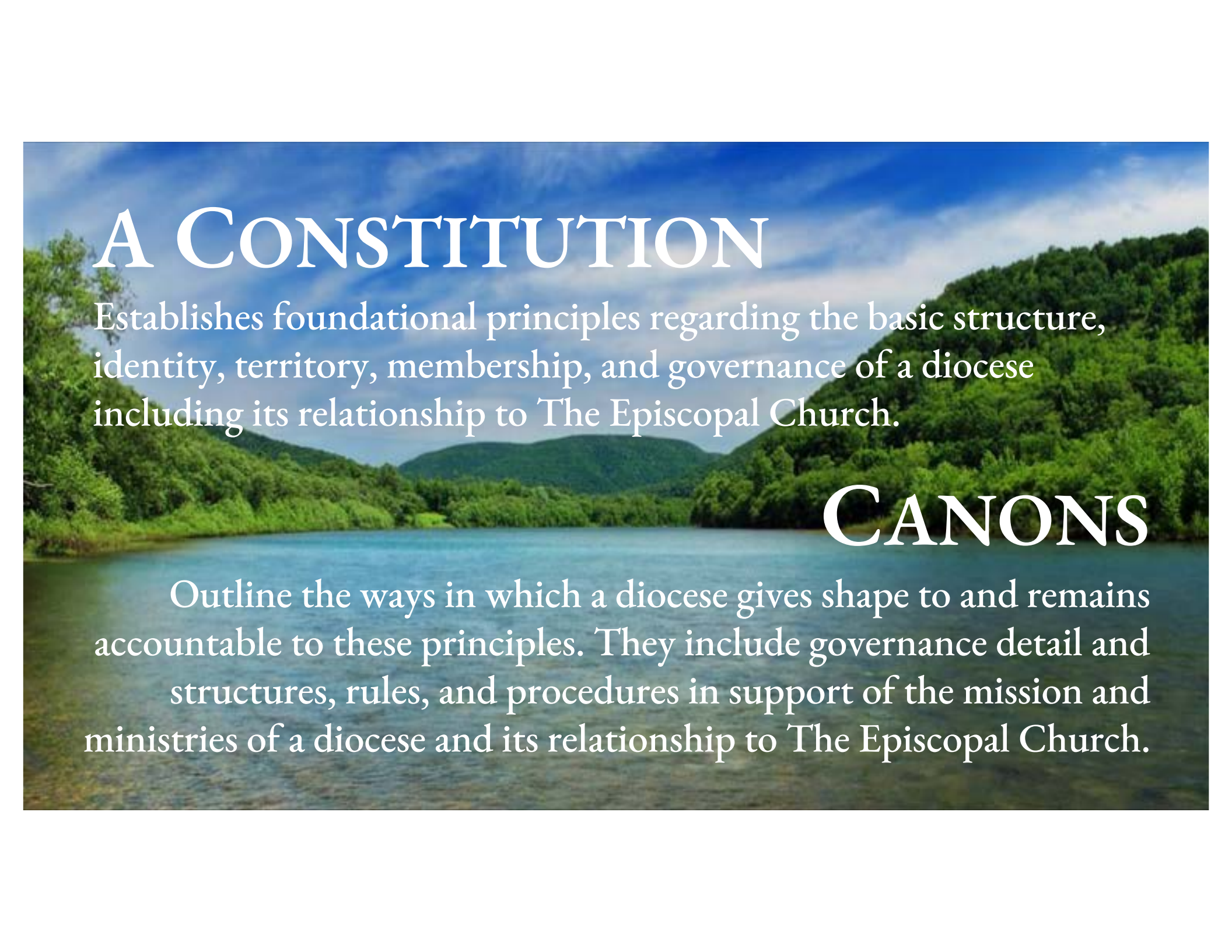

THE PROCESS SO FAR

- **January 2023:** Reunification Discernment Committee's C&C Team formed
- **January 2025:** Working Group on C&C formed to continue this work
- **June 2025:** *Drafts* of Transition Canons and the C&C for the Diocese of the Susquehanna shared and distributed throughout both dioceses
- **July 8-9:** Working Group hosts open Feedback Sessions
- **July 17:** Deadline for submission of feedback
- **August 2025:** Proposed Transition Canons and C & C submitted via resolution

THE PROCESS FORWARD

- **July 17:** Deadline for submission of feedback
- **July-August:** Working Group revises documents
- **August 2025:** Working Group submits the Proposed Transitional Canons and Constitution & Canons via a convention resolution
- **Pre-Convention:** Amendments to the Proposed Transitional Canons and Constitution & Canons may be pre-filed. Exact timeframe for pre-filing TBD.
- **October 2025** The Proposed Transitional Canons and Constitution & Canons will be moved for adoption, pre-filed amendments considered, and final forms adopted at our Joint Convention.



A CONSTITUTION

Establishes foundational principles regarding the basic structure, identity, territory, membership, and governance of a diocese including its relationship to The Episcopal Church.

CANONS

Outline the ways in which a diocese gives shape to and remains accountable to these principles. They include governance detail and structures, rules, and procedures in support of the mission and ministries of a diocese and its relationship to The Episcopal Church.

TRANSITIONAL CANONS

Serve as “a bridge” as we cross over into operating as one diocese. They focus primarily on how we will populate the leadership bodies of the Diocese of the Susquehanna.

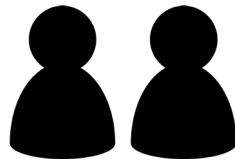

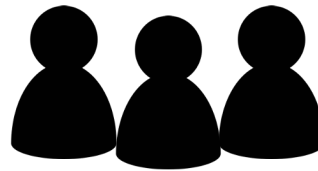

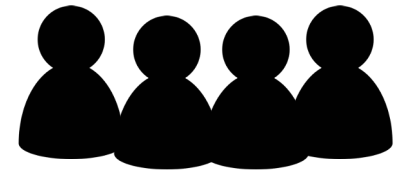
One LAY

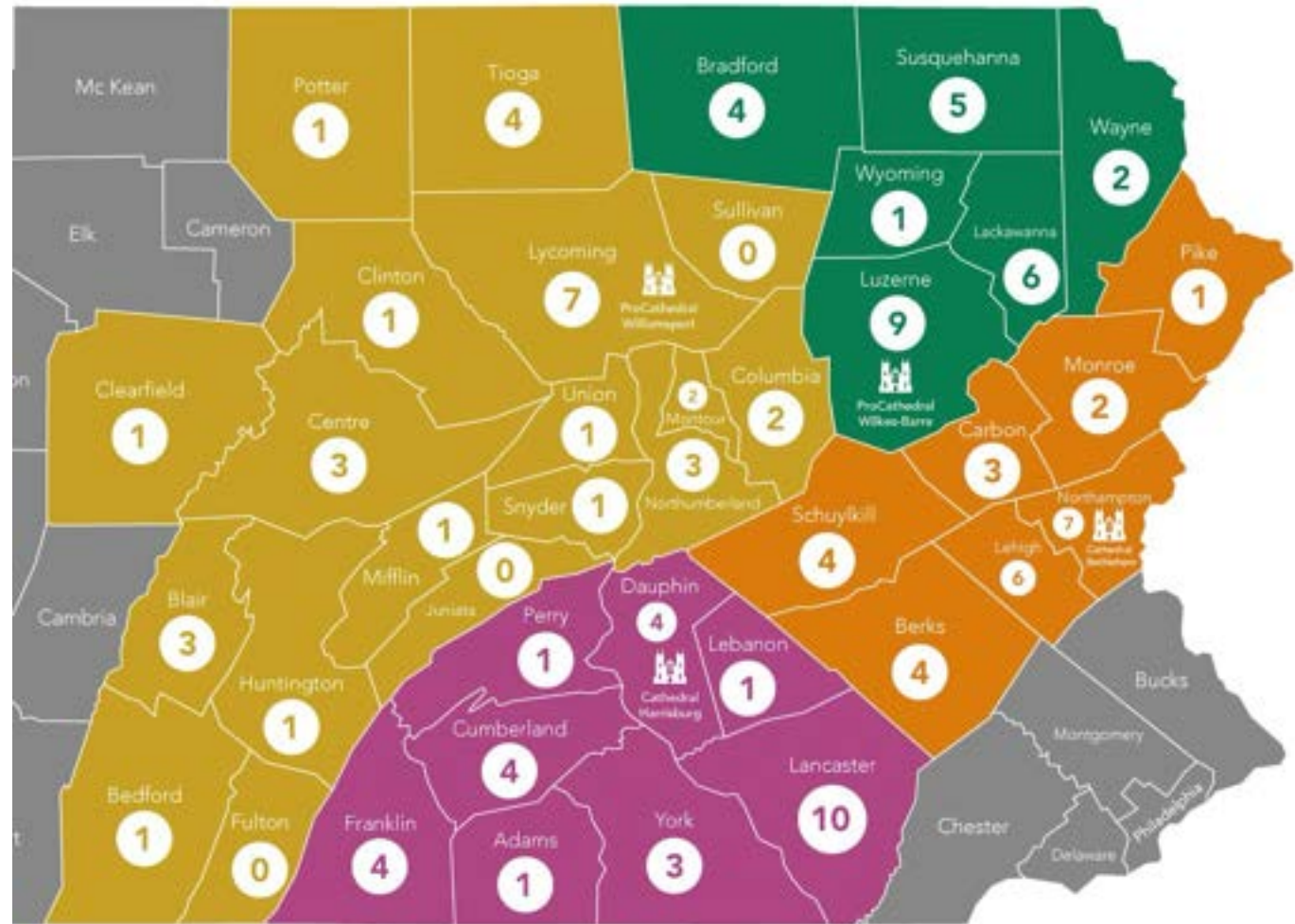
Title 1.Canon1.Section 1(b)

DIOCESAN COUNCIL

- 12 members plus the Bishop & Ex Officio members
- Ex Officio members are the Secretary, Treasurer, and Chancellor
- Each Convention elects four members: two lay and two clergy
- Three year terms with limit of two consecutive terms
- Duties of DioBeth's Diocesan Council and CPA's Council of Trustees for the Mission of the Diocese overlap significantly and will remain the same.

CONVOICATIONS

As recommended by the Reunification Discernment Committee, the Diocese will have four Regions with Convocations in each.

Since Convocations function very differently in each current Diocese, these draft Canons seek to provide flexibility by empowering Convocations to determine their agendas and composition.

Title I. Canon 5

CATHEDRALS

The draft canon on Cathedrals was originally drafted by the deans of our current cathedrals. It offers a definition of a Cathedral and a description of their mission - serving the diocese, as a local parish, and the greater community and region in a religious and civic role. The canon also offers detail regarding the various roles involved with leading a Cathedral - the Dean, the Bishop, the Parish Vestry, Honorary Canons, and the Cathedral Chapter.

IMPERILED PARISHES

In drafting this canon, the language of the two dioceses were reconciled, most closely resembling CPA's existing canons and streamlining DioBeth's.

We recommend that smaller congregations read through this draft canon and share feedback with the Working Group.

Title II.Canon 5

THE TRANSITIONAL CANONS

- Will go into effect immediately upon adoption and remain in effect until the first Convention of the Diocese of the Susquehanna.
- Focus primarily on populating leadership bodies
 - **Standing Committee**
 - **Diocesan Council**
 - **Commission on Ministry**
 - **Disciplinary Board**
- Include election of deputies to the 2027 General Convention

THE PROCESS FORWARD

- **July 17:** Deadline for submission of feedback
- **July-August:** Working Group revises documents
- **August 2025:** Working Group submits the Proposed Transitional Canons and Constitution & Canons via a convention resolution
- **Pre-Convention:** Amendments to the Proposed Transitional Canons and Constitution & Canons may be pre-filed. Exact timeframe for pre-filing TBD.
- **October 2025:** At our Joint Convention, the Proposed Transitional Canons and Constitution & Canons will be moved for adoption, pre-filed amendments will be considered, and final forms adopted at our Joint Convention.
